



## A shot at history Photography Competition 2021

Later this year, construction of the new clinical services building at Concord Hospital will be completed. We're inviting photographers to contribute to the collection of art in the new building.

We want to see your best photographic images that capture and reflect the local environment of Concord and surrounds.

### Selection

The winning images will be selected by the Concord Hospital Arts Steering Committee in collaboration with members of the hospital executive.

### Exhibitions

The winning photographs will be displayed across several media channels and platforms, including facebook, SydneyConnect, the hospital redevelopment website and at various locations across the hospital campus as framed prints or wall vinyls.

### How to enter

The photography competition is open to staff, patients, families, volunteers, consumers, students, residents and community members. Entrants must be aged 18 or over.

- Photographs should be original high-resolution images, suitable for printing (Note: iPhone images generally are not taken at high enough resolution)

- Up to five (5) photographs may be sent per entrant in one entry
- Images should be titled as:  
**Surname-First name\_Title of Work**  
(Eg. Bloggs-Joe\_Horse stables)
- A signed entry form must be completed for each entrant
- Images must be received no later than Friday 10 September 2021.

### Prizes

First prize will receive \$300 in prizemoney. Second prize will receive a two-hour private tutorial with an award-winning photographer. Prizes cannot be transferred.

### Entry Guidelines (Terms and Conditions)

- Each entry must only include original material created by the person named as the entrant.
- Each entrant can submit a maximum of five photographs electronically or via USB.
- Entries are only valid with a signed Terms and Conditions.
- The entrant grants Sydney Local Health District an exclusive, permanent, royalty free license to reproduce, publish, publicly display, and distribute the photograph, images of the photograph, or images of details from the photograph at any time in the future for internal use and promotional purposes including but not limited to being featured on any of the Sydney Local Health District, Concord Hospital websites (intranet sites and internet sites), Concord Hospital Redevelopment site, media and marketing material, promotional materials and other publications and sent to third parties for use in media and press releases.
- The photographs(s) must have been created in the last 12 months.
- The photograph(s) must have not been submitted to any other competition prior to this competition.
- The entrant must be the creator of the photograph(s) or make one if required.
- The entrant must own the copyright of the photograph(s).
- Copyright of the photograph(s) remains with the photographer subject to a license being granted to Sydney Local Health District (as detailed above).

- The entrant indemnifies SLHD against any claim, legal or otherwise, that may arise out of the publication of the photograph(s) or other use of the photograph(s) by Sydney Local Health District.
- A Release of Photographic Subject form must be signed by any identifiable person appearing in your photograph(s). For persons under the age of 18 years this must include the signature of their parent or guardian.
- You may not take photographs of any current patients within a Sydney Local Health District facility. Non-identifiable photographs are acceptable. Permission to photograph within a Hospital Unit is at the discretion of the Manager and must not cause distress to others. These must have signed consent forms.
- Artistic expression is encouraged but entrants should not submit photograph(s) that may infringe upon the rights of others, be defamatory or be in violation of the law.
- An entry must not infringe upon the copyright, trademark or any other intellectual property rights of any third person or violate any person's rights of privacy.
- Entries will be accepted up until 5pm on Friday 10 September 2021.
- By entering photograph(s) into this competition the entrant guarantees to SLHD that the above entry requirements have been met and these terms and conditions are accepted.
- Submission of photographs into this competition does not guarantee the photographs will be displayed or exhibited.

## Judging

- Only entries compliant with the Terms and Conditions of the competition will be considered eligible for the competition.
- Photographs will be judged on technical excellence, composition and artistic merit.
- A connection with Concord and its history should be recognised. Judging will be conducted by a panel constituted by SLHD employees and/or guest judges, to be selected by the SLHD Health and the Arts Steering Committee at its sole discretion. There will be no fewer than three (3) judges.
- Scores will be given out of 10, averaged and multiplied by 10 to give a final score out of 100 for each photograph.
- In the event of a tie, the entries which have tied will be re-submitted to the judges for a second consideration and a final judgement.

- All decisions (including scores) of the judges are final and will be binding on each entrant and final. No correspondence will be entered into.
- The top entries will be displayed at Concord Hospital and on the Concord Hospital Redevelopment website.
- Winners will be notified.

## Rights and Use of Photographs

- Each entrant retains all copyright to their photographs subject to Sydney Local Health District being licensed as detailed above. SLHD asserts no claims or rights for commercial purpose to any photographs entered into the Competition except as expressly set out in these Terms and Conditions. SLHD will only use entries in accordance with these Terms and Conditions or as otherwise specifically agreed between SLHD and individual entrants.
- Prize-winning entries and any such other entries determined by SLHD, will be displayed at various locations within the new clinical services building at Concord Hospital.
- Prize-winning entries and any such other entries determined by SLHD may be published on the intranet, internet and other publications such as a flyer, booklet or book and promotional materials.
- By submitting an entry, each entrant grants SLHD the licence detailed above.
- Each entrant agrees that their entry or entries may be edited or adapted at any time by the SLHD for legal, editorial or operational reasons.
- Submission of photographs into this competition does not guarantee those photographs will be displayed or exhibited.
